



## *ABRA Update #137 – July 6, 2017*

### **ACP Water Quality Hearing Dates for Virginia and West Virginia Finalized**

The Virginia Department of Environmental Quality (DEQ) and the West Virginia Department of Environmental Protection (DEP) have formally announced the dates for hearings and comment periods for considering applications for the Atlantic Coast Pipeline (ACP) to be certified in each state under the requirements of Section 401 of the Clean Water Act.

The June 30 announcement from DEQ calls for an overall comment period from July 3 to August 22 for draft water quality certifications for both the ACP and the Mountain Valley Pipeline (MVP) plus public hearings – 3 for the ACP and 2 for the MVP to be conducted in August (dates and locations below). Given the significance of the DEQ's consideration of the water quality applications for the two pipelines, a longer comment period is warranted. An effort is underway to achieve an extension of the comment period.

The draft certification documents for each pipeline (links below) upon which comments should be made are written with the presumption that the pipeline qualifies for receiving certification. Thus, the burden for persons submitting written comments or providing oral testimony at the hearings is to provide arguments as to why the ACP or MVP should not receive certification from the DEQ.

All persons concerned about the water quality impacts of the ACP and MVP are strongly urged to file written comments on the draft certification documents and, if possible, to participate in the public hearings.

The comment period concludes August 4. The North Carolina Department of Water Resources, as previously announced in *Update*, will conduct two public hearings on that state's Section 401 certification for the ACP, as follows:

- *Tuesday, July 18, 6-9 p.m.* – Fayetteville Technical Community College, Cumberland Hall, Fayetteville, NC. (sign-in for speakers at 5 pm),
- *Thursday, July 20, 6-9 p.m.* – Nash Community College, Brown Hall, Rocky Mount, NC. (sign-in for speakers at 5 pm).

## **Critical Missing Information on ACP Plans Sought from Virginia DEQ**

The lack of specific information about how the Atlantic Coast Pipeline (ACP) would be built without creating threats to water quality has hampered analysis of the project. The release last week of a draft water quality certification for the ACP (see link in article above) underscores the problem and prompted the Dominion Pipeline Monitoring Coalition (DPMC) to submit a Freedom of Information Request to the Virginia Department of Environmental Quality (DEQ). The [July 6 DPMC letter](#) seeks the following information for three specific locations along the pipeline route in Highland, Bath, Augusta and Nelson Counties that traverse steep mountain terrain and are thus susceptible to serious erosion problems:

1. Site-specific information describing erosion and sediment control plans, stormwater management plans, stream crossing plans, and slope stabilization plans for construction associated with the pipeline corridor, access roads, and other workspace;
2. Plan narratives, schematics, and site-specific plan view and cross-section diagrams of the pipeline corridor, access roads, and other workspace construction, showing the extent of excavation, the disposition of spoil, and the locations and specifications for erosion and runoff control and slope stabilization structures; and
3. All pre-construction and post-construction runoff calculations prepared to evaluate potential changes in runoff characteristics following construction associated with the pipeline corridor, access roads, and other workspace.

The DPMC letter, which is accompanied by maps of the targeted areas, seeks information for the pipeline corridor, project-related access roads, and all other projected-related workspace.
