SECTION 106 ENVIRONMENTAL INFORMATION REQUEST

Regarding the Treatment Plan for Rock Walls and Rock Features (007-5765):

- 1. Provide a schedule of when Atlantic Coast Pipeline, LLC (Atlantic) would reconstruct rock walls following restoration of the right-of-way.
- 2. Provide the name(s) and credentials of the professional stone setters who would be responsible for documenting, dismantling, and reconstructing the rock walls.
- 3. Describe the method of recordation the stone setters would use to ensure that the rock walls are removed and restored to their original condition.
- 4. Identify where Atlantic plans to store the rocks during construction.
- 5. Describe the procedures Atlantic proposes to allow members of the Augusta County Board and Augusta County Historical Society to visit the site while the walls are being removed and reconstructed.
- 6. Provide a mechanism for the Augusta County Historical Society to communicate with Atlantic's consultant, ERM, regarding local informants and additional documentation the Historical Society has collected on rock walls in the project vicinity.
- 7. Describe how Atlantic would ensure the popular report would be accessible to a non-professional audience and would be available via the internet and/or in the Augusta County Historical Society's Journal or Museum.
- 8. Describe how Atlantic's public outreach would also support local history and the mission of the Historical Society in educating citizens of Augusta County about their heritage. Consider similar components of the Treatment Plan for Warminster Rural Historic District (062-5160), page 12 and the Treatment Plan for the South Rockfish Valley Historic District (062-5119), page 12.
